Article 3 Contract Term

1. Provided the **Storage Services Agreement** has been concluded without using the **Storage Platform**, it shall take effect upon the **Storage**

Customer's receipt of the **Storage Services Agreement** undersigned by **astora** according to Article 13 of the **General Terms and Conditions for Storage Access**.

2. The Storage Services Agreement shall terminate at the end of the **Last Utilisation Day** for the **Storage Services** listed in Article 2.

Article 4 Operating of the Agreement

The details of the operational application of the **Storage Services Agreement** have been described in the **Operating Agreement** (Annex to the **General Terms and Conditions for Storage Access**). With reference to the **Operating Agreement** the following shall apply:

Article 5 Severability Clause

Should any individual provision or any part of any provision of this **Storage Services Agreement** be or become void or unenforceable the validity of the remaining provisions shall in no way be affected.

Article 6 Precedence of the Storage Services Agreement

In case of deviations and/or contradictions between the provisions of this **Storage Services Agreement** and the provisions of the **General Terms and Conditions for Storage Access** the provisions of this **Storage Services Agreement** shall prevail.

Article 7 Data Protection

astora processes personal data of the **Storage Customer**, respectively of representatives and employees of the **Storage Customer** or other involved persons appointed by the **Storage Customer** as described on the website of **astora** under "Data Privacy Statement". The concerned persons are entitled to the rights described there in more detail.

The **Storage Customer** will inform its data-processing agents, employees or other persons involved in connection with this contract of the aforementioned "Data Privacy Statement".
